The Director is responsible for hiring and training new personnel. The Director routinely communicates with outside agencies such as the Office of Child Protection, the Office of Community Services, the Office for Citizens with Developmental Disabilities and the Louisiana State Department of Health and Hospitals. The Director routinely attends weekly meetings with the consulting psychologist and monthly meetings with the consulting psychiatrist. Case

reviews, treatment plans, diagnoses, behavioral issues and medication intervention are topics for these meetings.

 - Reorganized community and residential homes to allow for more appropriate placement of residents.
 - Implemented a direct care staff committee to provide input to policy changes and training issues.
 - Redesigned staffing patterns in order to maximize the efficiency of staff during high needs times.
 - Changed the on-call system to provide increased support to direct care staff in order to improve service provision.
 - Assigned several direct care staff to become active in the AAMR Special Interest Group.
 - Facilitated the QMRPs to become active in the AAMR-LA Special Interest Group for QMRPs and hosted several meetings for this group.

 - Developed the day program to address residents with severe needs. This included designing programs, designing a relaxation room, and re-designing all training rooms.
