RE: Clients Screened but Determined Ineligible for Services/Programs

This memo describes options for billing screening services provided to individuals found ineligible for CCBHO services.

The **Early Intervention** service category was established in CIMOR to make available interim substance use disorder (SUD) services to persons who inject drugs that are placed on a wait list, for specific Department of Corrections pilot initiatives, and other non-CSTAR programs. **Behavioral Health Consultation with Report** is one of the services on the Early Intervention service category menu. It was developed so that providers that were requested by referral sources (i.e., schools, employers) to conduct screenings on individuals could receive reimbursement for the screening even if the individual was found ineligible for further services.

This process remains the same for CCBHOs and it remains a Fee for Service (FFS) activity.

The **CPS CCBHC SUD** service category is only for CCBHOs that do not have CSTAR programming, but have consumers that are eligible for SUD services.
