DBH Updates and Policy Guidance

March 8, 2019

1. **Budget Update** - The House Budget Chair has provided his recommendations for all Departments to the Budget Committee. The members of the Budget Committee have until Friday at 5:00 to turn in any amendments. Budget hearings for the House Budget Committee will continue on Monday where the Budget Committee members will be able to submit their amendments for approval. After the bills are voted out of the House Budget Committee they will go to the House floor for discussion and passage.

The supplemental request has been passed by the House and moved on to the Senate for their recommendations/approval.

Spring break for Legislators starts Friday March 15th and they will be back in session on March 25th.

2. **FY19 Funding at Critical Levels** - Fiscal staff have completed their financial analysis for FY2019 community obligations/contracts. Due to the level of projected federal earnings, at this time and until further notice please be advised that we will not allow the following:
 - Transfers of funding between agencies
 - Transfers of funding between contracts within a single agency
 - One-time funding
 - Funding over allocation within CIMOR will not be done.

This policy will be re-evaluated in May. Please contact Laurie Epple if you have any questions.

3. **CCBHC Summit at Compass Health Network** - On Thursday and Friday of last week Compass Health Network held a summit to discuss the successes of the Certified Community Behavioral Health Clinic (CCBHC) project in Missouri; a two-year demonstration project initiated by the 2014 Excellence in Mental Health Act, bipartisan legislation co-sponsored by Senator Roy Blunt. The meeting was hosted by Compass Health Network, National Council for Behavioral Health, and the National Association of Community Health Centers. In attendance were Department of Mental Health leadership, Missouri Coalition for Community Behavioral Healthcare, Missouri Primary Care Association, CCBHC expansion sites from across the nation, representatives from the Robert Wood Johnson Foundation, Missouri Foundation for Health, and the REACH Healthcare Foundation. Compass Health Network shared improved outcomes directly correlated to the CCBHC demonstration; workforce enhancements including additional staff positions leading to significant increased consumer access, system reforms including Open Access, Whole-Person Care, Zero Suicide screening implementation, and improved employee engagement and satisfaction. The two-day summit was wrapped up with a presentation by Craig Hostetler, "Connecting Value-Based Care & Value-Based Pay". The systemic improvements being realized from the CCBHC demonstration are changing the way Missourians in need of care gain access to treatment. Together, Missouri's CCBHC sites are promoting health and wellness to ALL populations resulting in lives being saved across the state.

4. **Update on Administrative Rules** – The final order amendment for the Behavioral Health Healthcare Home rule was published in the February 15, 2019 issue of the *Missouri Register*

The rules were moved from **DMH General Program Procedures to the DBH Core Rules** as **9 CSR 10-7.035**. The rule will be published in the *Code of State Regulations* on February 28, 2019, and **will become effective March 30, 2019**.

Proposed amendments for **9 CSR 10-5.190** Background Screening Requirements, and **9 CSR 30-3.230** Required Educational Assessment and Community Treatment Program (REACT) were published in the March 1, 2019 *Missouri Register* <https://www.sos.mo.gov/CMSImages/AdRules/moreg/2019/v44n5Mar1/v44n5a.pdf>

Public comments must be submitted as specified in the *Missouri Register*.

- 5. Family First Prevention Services Act** - A new [article in Governing](#) describes the Family First Prevention Services Act, which passed as part of the 2018 omnibus appropriations bill. The Family First Act addresses issues related to child welfare and substance use. Some provisions altered the allowable uses of Title IV-E (child welfare) funding so it can be used to pay for services before children need to be removed from their home. The bill also allows foster care maintenance payments to be made for children who live with a parent while the parent is in residential treatment for a substance use disorder. The legislation also amended the Regional Partnership Grant (RPG) program, an initiative managed by the Administration for Children and Families (ACF) within the Department of Health and Human Services (HHS), promoting increased State-level interagency collaboration by listing both the State child welfare agencies and the State alcohol and drug agencies as mandatory partners for the grant. *(this article from NASADAD update)*
