- 1. Budget Update Governor Parson has not yet signed the FY 2019 DMH budget bill.
- 2. Legislative Summary (as available) Here is a link to all bills that were TAFPed and their status: https://dmh.mo.gov/opla/legislativeupdatepage.html
  - Notes: A. HB2280 (Haefner) Expands MO HealthNet substance use and mental health benefits for pregnant women to provide behavioral health treatment for one year post-partum.
    - B. SB718 (Eigel) [TAFP, but not signed by Governor] stay tuned...good stuff in it, but I'm still reviewing!
- 3. **CSTAR Programs Not Yet Involved with STR** CSTAR programs that are able to implement the Medication First model for individuals with OUD are eligible for an STR contract! This funding can significantly increase access to evidence-based services! The new implementation manual is being updated, but you can read about the Medication First model here:
