DBH Updates and Policy Guidance

April 5, 2019

1. MATCP Conference - The Missouri Association of Treatment Court Professionals (MATCP) Conference was held March 25-27, 2019 at the Branson Hilton Convention Center. Over 800 professionals attended (judges, coordinators, prosecutors, defense attorneys, probation officers, physicians, treatment providers, peers, children's division case managers and many others). The conference provided more than 75 sessions with featured speakers such as Dr. David Mee-Lee, Dr. Shannon Carey, and Elizabeth Smart. A Veterans Treatment Court Boot Camp was held to train new mentors. Several DMH staff attended and those who made presentations included **Mark** Stringer who provided opening remarks, Dr. Angeline Stanislaus presented on medications for opioid use disorders, Rosie Anderson-Harper presented on Peer Support, and Jill **Richardson** presented on Family Support Providers. Our own **Angie Plunkett** was on the MATCP conference planning committee and was voted in as a MATCP Board member. She

Prior to joining DMH, she served as Director of Children's Services at Burrell Behavioral Health Central Region. She has experience working in community-based mental health, inpatient alcohol/drug rehabilitation, and in-home therapy settings.

4. Ozark Center's National Council Award - The National Council for Behavioral Health's Awards of Excellence recognize and honor individuals and organizations in behavioral health care for their ingenuity, hard work and dedication to improving the lives of Americans living with mental illnesses and addictions. After reviewing more than 230 impressive submissions from across the country, the National Council notified Ozark Center they were selected as the Excellence in Behavioral Health Care Management honoree for 2019. Ozark Center was honored for their excellence in developing trauma sensitive facilities across their organization. The award was presented at a banquet on March 26th at the National Council Conference in Nashville, Tennessee.



- 5. Economic Costs of the Opioid Crisis New <u>research</u> from the Missouri Hospital Association identifies the nationwide economic cost of the opioid crisis at \$685 billion in 2017, or 3.5 percent of GDP, with overdose deaths accounting for 93 percent of the cost. Missouri's toll is 20th highest among the states, with a total burden of just more than \$14 billion. Throughout a decade, Missouri's opioid overdose-related mortality rate increased by 107 percent. The research, modeled on a White House Council of Economic Advisors methodology and updated data from the Centers for Disease Control and Prevention, found significant increases in lost lives and economic costs through the second half of the decade. The growth in lives lost correlates with a significant increase in overdose deaths attributed to synthetic opioids, such as fentanyl.
- 6. New Resources from NARR The National Alliance for Recovery Residences (NARR) released an announcement highlighting two new publications: Helping Recovery Residences Adapt to Support People with Medication-Assisted Recovery and the National Standard 3.0 Compendium. The guide to medication-assisted recovery (MAR, the term used in the document by NARR) is tailored to the information needs of recovery housing operators and staff members. It discusses the basics of the most commonly prescribed medications, including how they work, how they are improving recovery outcomes, and how residences can become welcoming and supportive recovery environments. The National Standard 3.0 Compendium responds to requests from recovery residence operators and others interested in the genesis and application of recovery best practices. It is a detailed guide to the sources and rationale for the individual requirements comprising the standard. (taken from NASADAD newsletter)

- 8. MO-TAY-LER \$100,000 Award DMH's application to SAMHSA for the Missouri Transition Aged Youth- Local Engagement and Recovery (MO TAY-LER) Cooperative Agreement was recently awarded \$1,000,000 per year for up to five years. This is a Healthy Transitions Initiative working to improve life trajectories for youth and young adults, ages 16-25. Through MO TAY-LER, DMH will work collaboratively with Behavioral Health Network of Greater St. Louis (BHN), BJC-BH in St. Louis County, COMPASS Health in St. Charles County, and Places for People in St. Louis City to outreach, engage, and enroll transition-aged youth with significant behavioral health concerns in effective treatment. MO-TAY-LER's three overarching goals are to improve access to care for BH services, to create effective support in the transition from youth to adult services, and to develop advocacy and strategies to ensure funding and policies meet this population's service needs. DMH will work to move positive outcomes and lessons learned statewide.

- 9. Link Corrected for SOAR- (SOAR, (SSI/DI Outreach, Access and Recovery), A Step in the Recovery Process) The following link can be handy for the case manager trained in SOAR. The library contains an Application toolbox complete with worksheets, samples or forms and the Medical Summary Report along with other tools and worksheets to move you through the process. Remember, if your agency is not successful with SOAR there may be numerous reasons. Primarily consider your candidates for applications. If the individual is not experiencing homelessness or at high risk of homelessness, and/or does not have a mental illness, SOAR is not the appropriate tool. When you identify an appropriate candidate, use the tools available, including your local lead, (contacts list) to help you turn in a good application the first time. - 11. NIH study focuses on New Med for Cravings in OUD The National Institutes of Health Clinical Center (NIHCC) has started a clinical trial of an experimental medication designed to treat cravings associated with opioid use disorder (OUD). The NIH's National Institute of Allergy and Infectious Disease (NIAID) is helping to conduct the trial which will assess the safety of an experimental compound used to treat opioid cravings, and how it is processed in the body when given with another drug that is processed by the same liver enzyme pathway. Henry Masur, M.D., Chief of the Clinical Center's Critical Care Medicine Department stated in a press release, "At this time, there are few pharmacological interventions that specifically target the cravings felt by some patients who have physical dependence or opioid use disorder. This trial will lay the groundwork for future studies; together these may lead to effective treatments for the drug cravings that impede the pursuit of sobriety." The clinical trial is funded through NIH's Helping to End Addiction Long-Term (HEAL) initiative. (taken from NASADAD newsletter)
- 12. FDA Approves Esketamine Nasal Spray for Treatment Resistant Depression The Food and Drug Administration (FDA) on March 5 approved a fast-acting nasal treatment for treatment-resistant depression to be marketed under the name Spravato, intended to help adults who live with severe depression that has not responded to other treatments. The new drug, developed by Janssen Pharmaceuticals Inc., an arm of Johnson & Johnson, comes in the form of a nasal spray called esketamine, and can be effective within hours, rather than the weeks-or months-long stretches typical of other antidepressants in the marketplace. The drug contains an active form of ketamine, an anesthetic, which has been used off-label for decades to treat depression. It was abused [sic] on the streets in the 1990s and 2000s as "Special K," and can have powerful effects, including hallucinations, tunnel vision, and dissociative effects that make people feel untethered from their surroundings.

The FDA approval requires that doses be given in certified settings such as a doctor's office or clinic, and that patients be monitored for at least 2 hours in case of side effects, such as disassociation. In addition, the packaging for the new treatment will contain a so-called "black box" warning label, the most serious category, indicating potential sedation, problems with attention, judgment and thinking, as well as abuse and suicidal thoughts. The taking of an oral antidepressant must accompany administration of the spray. Two independent advisory panels, the Psychopharmacologic Drug Advisory Committee and Drug Safety and Risk Management Advisory Committee, approved the drug 14-2 in February, concluding the benefits of esketamine outweighed the risks, although some expressed concerns about the proposed risk-mitigation (REMS) procedures limiting access. The drug could help about 5 million people in the United States with major depressive disorder who haven't been helped by current treatments, about 1 in 3 people with depression. The list price of the drug will be \$590 to \$885 per treatment

session based on the dosage taken. Patients will receive the treatment two times a week for a month, then every week, and then every other week. (taken from NASMHPD newsletter)
