A FAMILY STAYS TOGETHER WITH THE HELP OF HOME MODIFICATIONS

When Mike isn't singing in the church choir, watching professional wrestling, dancing the night away, or attending events all over Kansas City, he is enjoying life at home with his parents.

Mike has Cerebral Palsy, so he needs additional physical supports to keep his balance. Home modifications to help Mike be more independent were completed in the fall of 2015 through the Department of Mental Health Partnership for Hope Waiver.

Mike has since been able to use the bathroom independently due to the grab bars installed in the shower and on the bathroom walls.

Additionally, a handrail leading down the basement stairs to the garage was replaced. This home modification has helped Mike to be able to independently access the family's vehicle. Mike wants to do all he can on his own to achieve his goal of true independence.

According to Mike's father, Michael Sr., "Every little thing helps him to stay safe and live with us as a family that much longer."

Mike's long-term goal is to move out and get married, but for now, he enjoys a fulfilling life at home with his loving parents, achieving his goal of independence with the help of home modifications.

Dental Student Training

In late March, the Division of Developmental Disabilities and several local providers partnered with the Missouri Oral Health Network (MOHN) and the A.T. Still Dental School to offer special care training to third and fourth year dental students doing their clinical practice in St. Louis. Training on day one included a lecture, video, and discussion. On day two, students had an opportunity to provide dental care under the supervision of licensed dentists to 25 individuals with Intellectual/Developmental Disabilities. Dental services provided during the training clinic included examinations, X-rays, prophylaxes, fillings, full-mouth debridement procedures, fluoride varnish treatments, and extractions. In addition to providing the dental students with valuable hands-on clinical experience, the volunteer patients benefited from free dental care valued at over \$7,000.

Robert Rada, DDS MBA, clinical professor at the University of Illinois at Chicago College of Dentistry, was the primary trainer. Several Missouri-based specialists assisted Dr. Rada, including John Dane, DDS FAAHD DABSCD, State Dental Director and former director of the Elks Mobile Dental program, and Vincent Lutterbie, former dentist at Marshall Habilitation Center. Organizations that brought volunteer patients to the clinical training included: Bridges, Arc of St. Louis, Emmaus Homes, Home Sweet Home, Magdala Group Homes, Bellefontaine, and St. Louis Developmental Disabilities Treatment Center (DDTC). Since 2009, training has been offered six times at various locations around the state for licensed dentists, dental assistants, and dental hygienists.

Home Modification Training Update

The Division of Developmental Disabilities (DD) contracted with Missouri Inclusive Housing Development Corporation (MO Housing) to provide training on home modifications for individuals who need modifications to better access their homes and community. Training has been provided around the state with 432 support coordinators, Regional Office staff, and staff from other agencies in attendance. Additional information including a [Home Modification Resource Guide](#) and other helpful tools are available on the Division of DD's website.

Training is now being planned for home modification providers who make the modifications and for the Occupational Therapists (OTs) and Physical Therapists (PTs) who provide evaluations required for home modification services. Information regarding training dates and venues will be announced as they become scheduled.

Home Modification Providers Needed

There is a great need for more contractors to provide home modification services as well as Occupational Therapists (OTs) and Physical Therapists (PTs) to provide home modification assessments in Missouri. In order for a contractor or therapist to provide home modification services and/or assessments through one of the DD waivers, the contractor or therapist must have a contract with the Division of Developmental Disabilities. A home modification contractor or therapist who is interested in obtaining a contract with the Division of Developmental Disabilities may contact the Provider Relations Team at their local Regional Office, or MO Housing at 855-444-5100. St. Charles Co. Holds Housing Conference



One hundred thirty one people registered to attend the St. Charles County Housing Conference held in Wentzville on May 5, 2017. Builders, developers, staff from agencies that support citizens with disabilities, individuals and families with disabilities, support professionals, and experts in the field of quality, affordable, universally-designed housing were in attendance. Panel discussions allowed for collaboration and participation by a broad spectrum of the housing community and the citizens it supports.

Topics included fair housing, universal design, building complete communities, and apprenticeship opportunities in the building trades. Keynote speaker Frank Montgomery provided the latest information from the U.S. Department of Housing & Urban Development.

The conference was an outgrowth of the success of the St. Charles County Housing Team. The housing team has grown to include many advocates interested in furthering the development of affordable, universally-designed housing in St. Charles County.
