Um, 39%, positive of all those, uh, individuals, 100 people get tested for.

For Kobe, with about 39 came out positive. That's a very high rate. So it's mainly the Southeast region that is currently the hotspot. So.

Facilities in the Southeast region, if you are having staff, and if you want to do screening more screening testing, um, scanning for symptoms, testing screening for exposure.
