Similarly, as Emily mentioned in 995, Missouri implemented its Mo kid waiver, and the targeted population is children with developmental disabilities, the division currently has the capacity to serve 366 participants in this waiver.

And the last Mocha waiver renewal application was approved by centers for Medicare and Medicaid services or CMS effective July 1st, 2018. so the next wave of revenue renewal will be in 2023.

Some important facts about the MO, kids waiver waiver, serves 366 children and does not have an annual cost cap. The child must be determined not eligible for any Mo, health net program.
