In March, the Office of Disaster Services staff participated in a SEMA led tabletop exercise for repatriation. These exercises are held a few times a year to ensure best practices are used when assisting US citizens returning to the United States following an evacuation

from a country that has experienced a disaster or a form of international crisis. Many state and federal agencies, as will as non-profit organizations, participate in repatriation. Some include: Dept of Defense, Dept of Social Services, American Red Cross, Transportation Security Administration, Customs & Boarder Patrol, SEMA and DMH. (This is not an exhaustive list of agencies and organizations that participate.)

Peputy Director for the Office of Disaster Services, Alyssa Backes, led Central Office in STOP THE BLEED Training in March. During training, participants were taught how to recognize life-threatening bleeding and how to control that bleeding effectively, through a combination of classroom and hands-on instruction.





BEHAVIORAL HEALTH STRIKE TEAM training was held on April 11th. This training will be held again June 1st. During this training, Frank Zenere a school psychologist and District Coordinator of Student Services/Crisis Program from

Miami-Dade County Public Schools, discussed his response to numerous state and national crises that have occurred with the main focus on school shootings.
