FUNDING OPPORTUNITIES

1. **New Supporting Justice, Behavioral Health and Housing Collaborations through Federal Funding** – Federal funding can be a key source to support the piloting, initial operations, or expansion of interventions that serve people with behavioral health needs in the justice system. These grants are also often paired with training and assistance to help communities through the challenges of advancing and sustaining new collaborations. **Read More**

- 2. HRSA Funding Opportunity: Screening and Treatment for Maternal Mental Health and Substance Use Disorders The Health Resources and Services Administration (HRSA) recently announced an \$8.75 million funding opportunity for Screening and Treatment for Maternal Mental Health and Substance Use Disorders. This grant program is open to States, Tribes, and Tribal organizations, and aims to "... expand health care providers' capacity to screen, assess, treat, and refer pregnant and postpartum people for maternal mental health and substance use disorders (SUD). This will be accomplished by establishing, improving, and/or maintaining statewide or regional1 networks that provide real-time psychiatric consultation, care coordination support services, and culturally and linguistically appropriate training to maternity care providers and clinical practices." This program will offer up to 14 awards of up to \$750 thousand per award. Application Due Date: Friday, June 2, 2023.
- 3. Strategic Prevention Framework Partnerships for Success for Communities, Local Governments, Universities, Colleges, and Tribes/Tribal Organizations The purpose of this program is to help reduce the onset and progression of substance misuse and its related problems by supporting the development and delivery of community-based substance misuse prevention and mental health promotion services. The program is intended to expand and strengthen the capacity of local community prevention providers to implement evidence-based prevention programs. Application Due Date: Monday, June 5, 2023. - 4. **Request for Proposals-Opioid Crisis** The City of St. Louis Department of Health seeks proposals for activities to address the Opioid crisis in the City of St. Louis by improving access to substance use treatment and recovery, furthering overdose prevention and harm reduction efforts, and providing services for those at high risk for overdose. **Application Due Date:** *Tuesday, June 6, 2023.* <u>Learn More</u>
- 5. **New Behavioral Health Partnership for Early Diversion of Adults and Youth** The purpose of this program is to establish or expand programs that divert adults and youth with a mental illness or a co-occurring disorder (COD) from the criminal or juvenile justice system to community-based mental health and substance use disorder services (SUD) and other supports prior to arrest and booking. **Application Due Date: Tuesday, June 9, 2023.** <u>Learn More</u>
- 6. Minority AIDS Initiative: The Substance Use and Human Immunodeficiency Virus Prevention Navigator Program for Racial/Ethnic Minorities is a \$10.3 million funding opportunity that aims "...to provide substance use and HIV prevention services to racial and ethnic minority populations at high-risk for substance use disorders (SUDs) and HIV infection." - 1. **New Disaster and Preventive Psychiatry Course** This 9-module course is interactive and will cover topics including: the basic concepts in disaster and preventive psychiatry, psychological and behavioral effects of disasters, risk and vulnerability to disasters, psychological first aid, risk and crisis communication, leadership consultation, and preparedness for disasters. It is designed for a broad range of healthcare workers, disaster responders, and community leaders. - 2. **New Youth Suicide Rates Increased during the COVID-19 Pandemic** In a new study supported by the National Institute of Mental Health, researchers analyzed national suicide data to understand the impact of the COVID-19 pandemic on youth suicide rates in the United States. They identified an increase in suicide deaths during the pandemic that varied by factors including gender, age, race and ethnicity, and suicide method. Read More

- 4. **New Study Shows Naloxone Expansion not associated with Increased Heroin Use among Teens** A new study from researchers at Columbia University and published in the International Journal of Drug Policy found that adoption of laws to increase naloxone access was not associated with a meaningful change in drug use rates, including heroin use among teens. Read More
- 5. **New New Opioid Overdose Reversal Nasal Spray Received FDA Approval** The US Food and Drug Administration (FDA) announced on Monday that it has approved a new opioid overdose reversal nasal spray for patients at least 12 years of age. Read More
- 6. **New** An Innovative Strategy to Access Harm Reduction Resources Increasing access to empirically supported harm reduction resources, including naloxone, safer injection kits, and fentanyl test strips, could help prevent overdose deaths and other drug use related harms. This study evaluated the impact of an automated harm reduction resource machine on the accessibility of harm reduction supplies and the local incidence of fatal overdoses and HIV during its first year in operation. Read More
- 7. New Relationships among Discrimination, Alcohol Use, and Mental Health are Complex and Variable for Young Men that Identify both as Racial and Sexual Minorities Young Black and Hispanic men who have sex with men (MSM) report more harmful alcohol use and higher rates of depression compared to young heterosexual men. Theory suggests these health disparities may be linked with experiences of discrimination related to their sexual and racial/ethnic identities. This study examined how experiences of discrimination were associated with depression and alcohol use over time among a sample of youth racial and sexual minorities. Read More
- 8. **New Large Youth Study Reinforces Importance of Addressing Substance Use in Mental Health Treatment** Mental health concerns and substance use often co-occur, particularly among adolescents and young adults. This study identified common patterns of their co-occurrence for adolescents receiving mental health treatment to inform best practices for this age group. Read More
- 9. **New Population Study Finds Depression is Different Before, During and After Pregnancy** New research funded by the National Institute of Mental Health tracked population-level rates of postpartum depression among new mothers before, during, and after pregnancy. This study's findings support the idea that pregnancy and postpartum are risk periods for maternal mental health. <u>Read More</u>
- 10. **DEA Requirements for Prescribers** All DEA license holders will be required to take an 8-hour course on the treatment and management of patients with opioid or other substance use disorders.
