Body U	Ellen Fitzsimmons-Craft gave an update on the Office of Women's Health Grant. Connie Flachs will work full-time on this at the beginning of June. They have been working on continuing to solidify partnerships with three (3) initial school districts, which is Rockwood, Clayton and Columbia, with plans to work to implement the screen

360 Training	process starting in August with those districts. They are working now to develop personalized implementation plans and working on finalizing the content for the team versions of the program and working with 3C to get that programmed on their platform. They are looking for teenagers that are passionate about body image, eating disorders and wellness to review the new content and offer feedback. The most exciting Body U update is that the Institute is ready to launch the new platform messaging feature on June 5 th , we really think this is going to enhance user's engagement with their coaches. Ellen Fitzsimmons-Craft gave an update on 360 trainings. They have hosted 4-week series and exposure therapy for the treatment of eating disorders. They had 238 registrants, which 57 registered officially for the continuing education credits. They had positive feedback from the training. They have an additional training on the co-occurrence of eating disorders and substance use. On June 2 nd they have a training on Health At Every Size 101 – the importance of weight inclusivity care.
