The Missouri Alliance for Dual Diagnosis (MOADD) was established in 2018 to bring awareness about the support individuals with an intellectual/developmental disability (I/DD) and a behavioral health diagnosis need and

to initiate change in the service delivery systems.

Through the MOADD ECHO, efforts are focused on helping to bridge the care gap of services for children with dual diagnoses. MOADD ECHO, which is a collaborative effort between MOADD and ECHO Autism Communities, provides a real-time virtual opportunity for professional mental health providers, state agencies, and service delivery systems to focus on best practice approaches and brainstorm available resources. 2024 Disability Rights Legislative Day


