




DEDICATED TO THE HEALTH OF ALL CHILDREN™

A <u>policy statement</u>, dated May 28, 2024, from the American Academy of Pediatrics provides guidance to pediatricians on how to help teenagers with intellectual and developmental disabilities (IDD) and their families navigate the transition to adulthood with regards to their healthcare. The policy statement outlines considerations of steps pediatricians should take, which includes starting conversations with the youth and the youth's support care team about healthcare decision-making. These conversations should begin when the youth is between the ages of 12 and 14 years old. The policy further suggests pediatricians should promote autonomy in their patients and support the least restrictive alternative method of decision-making necessary that meets their patient's needs.

Pediatricians should become familiar with the needs related to basic human rights and dignity for people with IDD, understand current terms and concepts in decision-making, and know what the current alternative decision-making processes are from least to most restrictive. Lastly, the policy statement provides practitioners with a list of resources to explore that promote autonomy, self-advocacy, person-centered planning, and decision-making alternatives.



A Division priority is to provide timely updates to all stakeholders on the ConneXion Case Management System Planning and Procurement Project. ConneXion has a dedicated <u>webpage</u> with updates and information about the project.

The Division is seeking a new electronic case and financial management system to support the lifecycle of consumer care including information and referral; intake; assessment and reassessment; person centered care planning and service authorization; service delivery and payment; case closure; and reporting. The Division is currently in the Planning and Procurement phase of the project. The Division anticipates a Request for Proposal (RFP) will be released for bid in summer 2025.
