## DBH Updates, Notices, and Policy Guidance June 21, 2024

- New CVS Priority Notice! The long-awaited Visit & Services list for visit eligible CCBHC services has been updated on the DMH CCBHC website. You can reference the list here: <u>Certified Community Behavioral Health Clinics (CCBHCs)</u> <u>http://dmh.mo.gov</u>, information for Providers, CCBHC Visit Service List 06/2024. If you have any questions/concerns, please submit them to the DBH Support Center through the <u>provider portal</u>.
- New CVS Priority Notice! As discussed, timely filing requirements are being reinstated on July 1, 2024, and DBH will be "closing" old visits. Any incoming claims will hit regular editing for timely filing as outlined below. Keep in mind that Medicaid processing times must also be met for timely filing. This means claims need to be submitted in time for CVS to process all claims to MHD prior to the timeline below.

Original Claim1 year from date of serviceReplacement Claim2 years from date of serviceVeid Claim2 years to process through CVS

**Void Claim** 3 years to process through CVS, over 3 years must go through MMAC self-reporting process. In addition to inbound claim edits, CVS will not allow any processing on an original or replacement claim that is currently in process but has past timely filing. These visits would have been reported on the Outstanding Payment submission. Therefore, all visits that are <u>2 years past the date of service</u> will automatically be <u>closed</u>. The visit will show a message on screen stating, "<u>Visit closed on DATE, no further processing allowed</u>." All visits from 2017 to June 30, 2022, will be closed by July 1. After that time, visits will be closed daily as timely filing of 2 years from the date of service has passed. Any visit already in process to Medicaid or CVS invoicing will continue to finish the payment process.

3. New 2<sup>nd</sup> Annual EPICC meeting – On Wednesday, June 12, 2024, the Engaging Patients in Care Coordination (EPICC) program, supported by DBH and hosted by the Missouri Hospital Association (MHA), held its 2<sup>nd</sup> annual statewide meeting in Jefferson City. EPICC Certified Peer Specialists, EPICC Clinical Coordinators, DMH Staff, and other stakeholders were in attendance. The events included a talk by Dr. Jeanette Simmons, DBH Deputy Director; a learning session by Dr. Doug Burgess on responding to maternal substance use disorder patients and treatment options; and intramuscular Naloxone 101 training. Additionally, peers had the opportunity to speak with DMH's Rachel Jones, Director of Trauma Services, who presented information on the importance of wellness and self-care.



- 4. New Knowledge-Building Webinar: Short-Term Retention Strategies Andrea Kimball, Director of Quality and Compliance and Jennifer Johnson, Deputy Director of Community Operations, presented at the "Knowledge-Building Webinar: Short-Term Retention Strategies" for the National Association of State Alcohol and Drug Abuse Directors (NASADAD), through their Single State Agencies Systems Technical Assistance (SSA-TA) project. The webinar, hosted on June 20, 2024, included details regarding Missouri provider and state approaches to retention strategies including results from a behavioral health workforce survey, block grant funding, policy updates, the associate degree in behavioral health support, and addiction fellowships. Several states joined including Idaho, Indiana, Kentucky, Louisiana, Pennsylvania, and Vermont wrapping up the NASADAD led 8-month learning collaborative on workforce development. Additionally, there are plans to highlight Missouri as a brief case example for retention strategies."
- 5. New Earlier this week, Beckie Gierer, Director of DMH Office of Disaster Services presented to the National Association of State Mental Health Directors. Beckie presented on Missouri's disaster behavioral health program which includes the MO Behavioral Health Strike Team (BHST). MO's BHST is unique as only a handful of states in the country have teams like this and they fill an important role in disaster response and recovery in each community in Missouri.
