Urban vs Rural

- 👤 “Urban” vs “Rural” no longer exists in the new WAIVER rate methodology
- 👤 Urban vs Rural will only exist in the room and board methodology – and only until we can convene and determine what that rate should be

Pending Rate Structure

- 👤 Daily rate is based on 3 Tiers
- 👤 Daily rate is all encompassing
 - 👤 Host/companion costs
 - 👤 Professional manager
 - 👤 Administration
 - 👤 Relief (no more variance reporting)
- 👤 Default process for initial SL budgets

Determining the Rate

- 👤 Providers will no longer submit budgets
- 👤 SC's will use a rate determination form
 - 👤 If a person's current daily rate is higher than the new rate structure – the current daily rate remains in place until either
 - 🏠 A new RAS is completed that increases the rate within the new structure or
 - 🏠 The Enhanced FMAP maintenance effort ends
 - 👤 No individual waiver budget adjustments

Process for 7/1/22 rates

- 👤 Central Office will update all Shared Living Authorizations back to 7/1/22 and rebill
 - 👤 *If a person's current daily rate is higher than the new rate structure – the current daily rate remains in place until a new RAS increases the rate under the new rate structure OR the Enhanced FMAP maintenance effort ends*
- 👤 PR will send a list to providers to verify and we will correct if errors are found

Future Enhancement Planning

- 👤 We are working on a modifier for the SL RN oversight and plan to match the rate with ISL and GH oversight until then it remains authorized as PAMS which will increase to \$20.29 when approved
- 👤 In ConneXion we hope to have billing codes specific to each RAS for Host and Companion so that the SC can just select the correct code associated with the RAS.

Out of Home Respite

- 👤 **MUST** be Certified for Out of Home Respite before billing to respite
- 👤 Can only be provided at locations where there are no authorizations for Host Home services.
