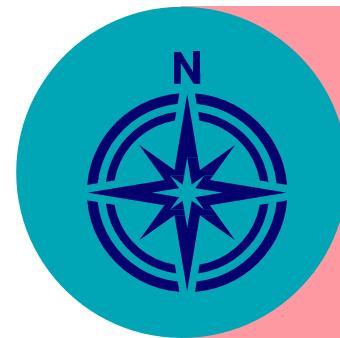

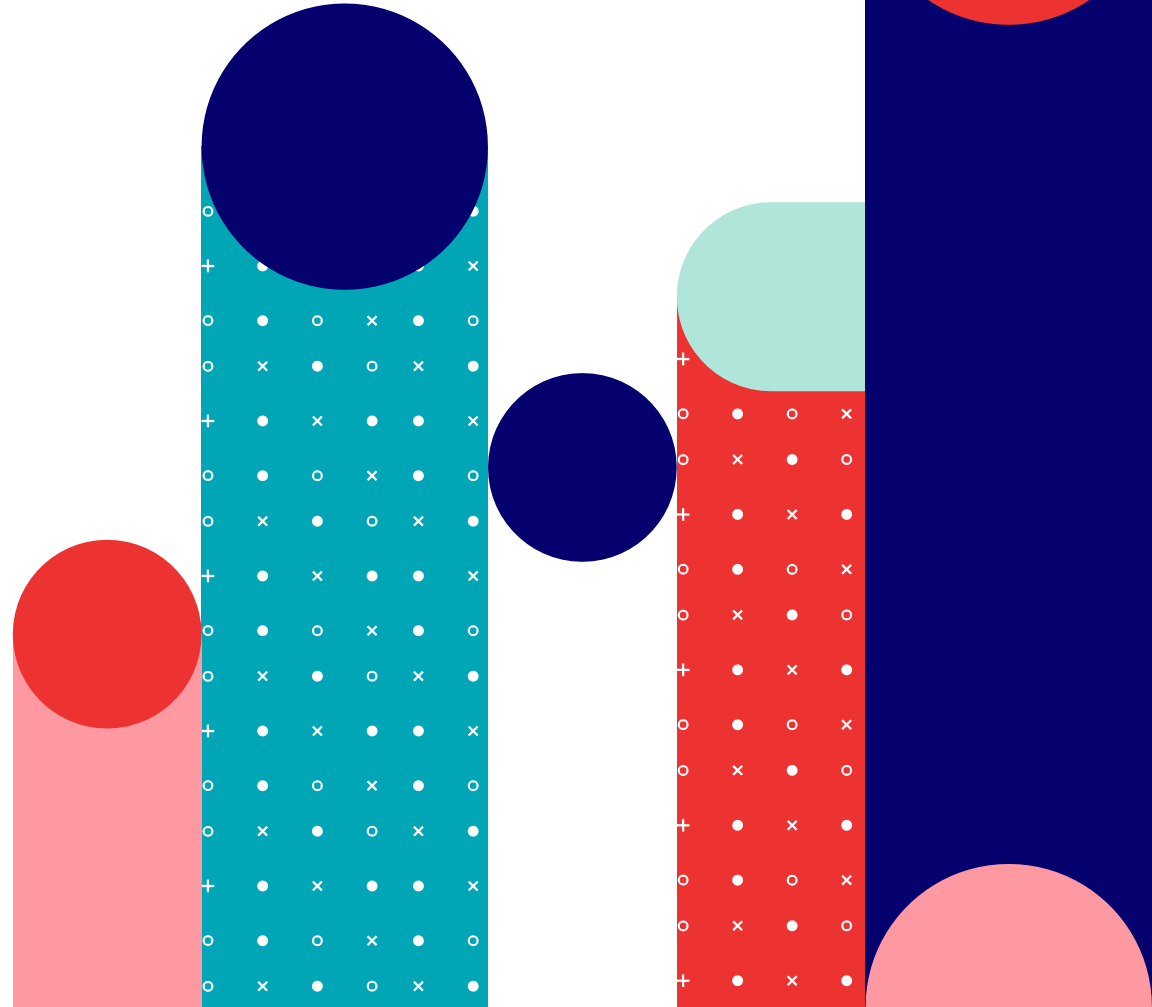

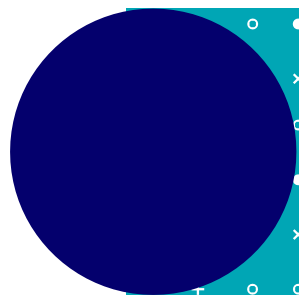

What is Behavior Support Review Committee?

The Behavior Support Review Committee is the Divisions' way to provide support to teams across the state who provide services to individuals exhibiting complex needs through clinical consultation and follow-up coaching. The overall goal is to promote the implementation of best practice strategies leading to greater independence and an enhanced quality of life.

Who is the Behavior Support Review Committee?

It consists of the following:

- Three regional licensed behavior analysts who function as the chairpersons of the committee along with three Intensive Systems Consultants
- A member or members of the provider community licensed to practice applied behavior analysis or working towards licensure
- Other professionals as necessary to review the information and provide feedback

- Receiving Intensive Therapeutic Residential Habilitation Services

Required Attendance at Behavior Support Review Committee as a Tier 3 Behavior Analysis Team



What factors identify the need to attend the Behavior Support Review Committee?

Required attendance is based on any of these criteria:

- Significantly Challenging Behavior
- Reactive Strategy Threshold being met
- Having Psychotropic Medication or PRN used for behavior control
- Referrals - self or other
- Prohibited Procedures are used
- Receiving Intensive Therapeutic Residential Habilitation Services



Attendance Notification

- Based on CIMOR information and support from the Identified Points of Contact for the Regional offices
 - Sent as Calendar Invite with attachments
 - Letter
 - Identifies the criteria/basis for need to attend
 - Outlines expectations for required materials and attendance
 - Case Review Form
 - Reminder sent through out the process based on responsiveness of teams and team needs

Who can be a Committee Member for the Behavior Support Review Committee?

Committee members are volunteers from educational institutions and community settings who are certified in Applied Behavior Analysis or working toward BCBA/BCaBA certification under a Licensed Behavior Analyst.



Behavior Support Review Committee Member Responsibilities

WHEN FIRST BEGINNING THE COMMITTEE MEMBER JOURNEY

- Identifying availability for participation
 - Accept Calendar Invitation for Participation
- Contact Committee Chair to complete as identified and necessary
 - Volunteer screening
 - Required trainings



MEETING PREPARATION

- Receive REDACTED plan information seven days prior to the meeting date
- Review plan information
 - ISP and BSP if one is available
 - Complete the BSP Checklist, only if a BSP is being reviewed
 - Return the BSP Checklist approximately three business days prior to the meeting



MEETING ATTENDANCE

- During the meeting the Committee members will
 - Identify who they are, the organization they are from and their role when
 - Ask clarifying questions and provide recommendations
- Committee member will notify chairperson when they cannot attend scheduled meeting and the committee member will notify chairperson when they need to step down from the committee

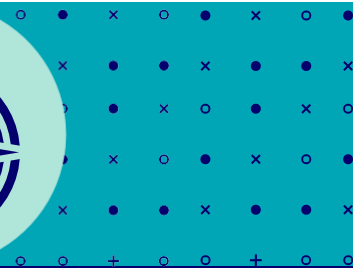
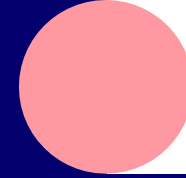
Coaching and Action Planning

- Coaching is a process that aims to improve performance and focuses on the 'here and now' with application to develop capacity for the system within the Team - SC, Provider, Guardian etc
- The Coach is not a 'coach as expert' in all things but, instead, the coach is a facilitator of process.
- The Coach is helping the team to improve their own performance: in other words, helping them to develop better systems.



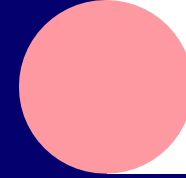
Coaching and Action Planning

- Action Planning is turning your vision into reality. And what's your best way to avoid challenges and problems during this journey.
- An action plan generally would include:
 - A description of the goal to be achieved
 - Tasks/ steps that need to be carried out to reach the goal
 - People who will be in charge of carrying out each task
 - When will these tasks be completed (deadlines and milestones)
 - Resources needed to complete the tasks
 - Measures to evaluate progress

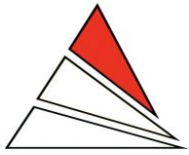


Coaching and Action Planning

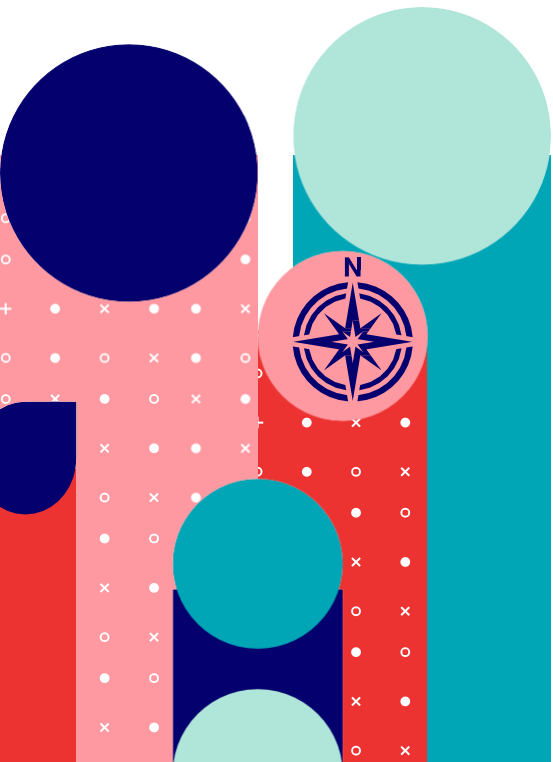
- **Coaching and Action Planning occurs at various levels and in various ways within the MTSS Team**

 - **Related to Specific Process**

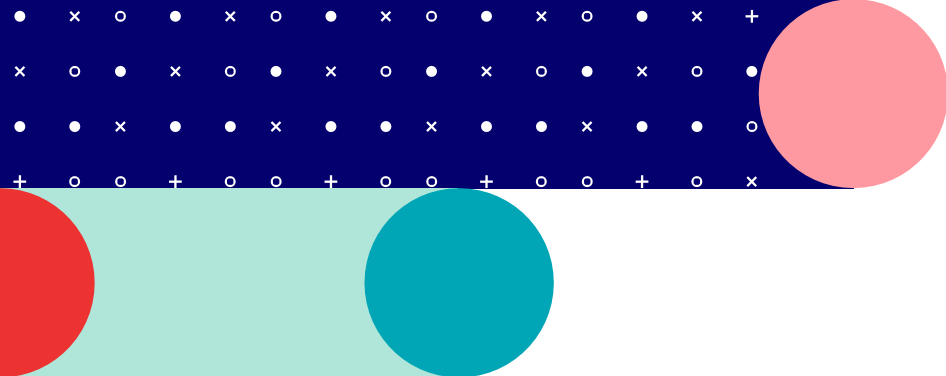
